

TusCon Dealer's Room Information{ TC \11 }

TusCon 34 will be November 9-11, 2007. TusCon will be at the Inn Suites. The hotel is located and I-10 and St. Mary's Rd, 475 N Granada, 520-622-3200(local) or 1-877-446-6589. Our guest of honor is **John Ringo** with toastmaster **Ed Bryant**. We are expecting between 300 and 350 attendees.

The Dealers' Room will be in the same space as last year. There will be approximately 24 tables. The maximum table limit will be three (3) tables per dealer.

Dealer memberships are \$50 for a six (6) foot table and include one (1) full convention membership. If you plan on having a second person with you at your table, that person must have a convention membership at \$40 a person (if paid in advance, \$45 at the door). The more tables, the more memberships you will have.

All dealers are required to fill out and return one copy of the enclosed dealer's agreement form by mail. Payment must accompany the agreement or you may pay with PayPal -see our website at <http://home.earthlink.net/~basfa>. If using PayPal make sure you say dealer's table in the comments.

If you need to cancel, contact us at least four weeks in advance for a full refund. Cancellation with two weeks notice will bring you a refund of half your table cost. Less than two weeks notice will forfeit your refund.

By signing the dealer's agreement, the dealer agrees to comply with the civil laws, rules and regulations concerning any activities and/or sales at TusCon 34. If the dealer fails to comply with said rules, or with any portion of this agreement, the ConCom may, upon notification, take immediate steps which in their sole judgment may be necessary to protect TusCon 34's interests, including but not limited to the closing of the said dealer's table, removal of the dealer's sales materials, removal of the dealer, and halting of dealer's activities on the hotel's premises with full forfeiture of monies paid.

Please take note: We are not reserving tables this year without payment.

TusCon 34 Dealer's Agreement

You must reserve and pay for your table in advance. Refunds on canceled tables will be given if the convention is notified four (4) weeks in advance of Nov. 9, 2007. If two weeks notification is given a refund of one-half the table price will be given. Any cancellation received less than two weeks before the convention will forfeit the table price.

Dealers will be responsible for all materials they bring into the Dealers' Room. The Convention Committee will ensure that the Dealers' Room is secure when it is not open for business or set-up. During the periods that the Dealers' Room is locked, any Dealer who has sufficient reason to enter the room must do so in the presence of one of the Convention Committee. The Convention Committee will not be responsible for security within the Dealers' Room.

The Hotel has been instructed that no Dealer will be allowed to enter the Dealers' Room before the noon set-up on Friday, November 9, 2007. Please remember that there is **NO SMOKING** and **NO FOOD** not provided by the hotel in the Dealers' Room.
