All Breed ASCA Sanctioned Agility Trial

At the Flying E Ranch

Villa Creek Rd., Cayucos, California

Saturday & Sunday, August 15 & 16, 2009

Saturday's classes: Two Regular & Two Gamblers

Sunday's classes: Four rounds of jumpers;

Offered in the Standard, Veterans and Junior Handler divisions.

This trial will be limited to 300 runs per day.

Judge: Judy Boone, Utah

Pre-entries will open on June 24th, 2009, and will close (must be postmarked no later than) August 1, 2009.

If this trial does not fill, day of show entries will be taken from 7:30 - 8:00 a.m. on August 15th. Contact Sue Graham (909-596-8452) before August 7th for of day of show entry information.

Entry confirmations will be emailed by Wednesday, August 5th.

RULES & MISC. INFORMATION

COAST will offer ribbons for 1st through 4th place in each class for each jump height division (dogs jumping 24" optionally will be combined with the 20+ class); High in Trial rosettes and awards for HIT Veterans, Jr. Handler and Novice, Open and Elite in the Standard Division. (7 pts for elite full Q's, 6 pts for open full Q's, 5 pts for novice full Q's, ½ that point value will be assigned for faulted Q's - the class level in the regular class will determine the HIT award level). Green ribbons will be offered to every dog obtaining a qualifying score.

The agility field will be outside on grass with a patch or two of dirt. Bring your own shade, the weather should be cool enough to work out of your vehicles too.

The trial will be held under the current rules and regulations of ASCA® (Australian Shepherd Club of America). Exhibitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of and agree to abide by all rules in effect at the time of this trial. A copy of ASCA®'s Agility Rulebook may be downloaded free from the ASCA® web site: www.asca.org.

Equipment list: Jumps, tunnels, weave poles, 'slat-less' contacts: dog walk, A-frame, teeter.

An ASCA registration number is not required for entry, but is required to obtain titles and to have qualifying scores tracked. Please see the attached form for a tracking registration number. Entries will be accepted on the basis of postmark date. Please do not send entries early. On any given day that the trial would fill with the entries postmarked that day; those entries will be drawn at random. Entries will close and must be postmarked by August 1, 2009, to avoid day of show (if available) entry fees. Confirmations will be emailed to all who pre-entered. ☺ **PLEASE FILL IN YOUR EMAIL ADDRESS ON THE ENTRY FORM.** ☺ Every entrant must be in good standing with ASCA®. No entry will be accepted from any dog or handler disqualified from the ASCA® Agility Program or all ASCA® programs. Brad's cook-shack will be open for hamburgers & veggie burgers during lunch. All volunteer workers will have lunch provided if you can work at least two classes. If you would like to join us for the BBQ dinner after the trial on Saturday, please let us know on your entry form.

All dogs must be on leash when not competing in the ring. This includes hiking/walking on the hills and pastures - please NO DOGS OFF LEASH unless they are on the agility course. Please clean up after yourself and your dog and no smoking outside of vehicles.

****This trial will be held on the same grounds as the Cayucos Cup Stockdog Trial. Please be aware of the activities in the stock arenas and keep away from the arena fences while dogs are trialing.****

Overnight parking (dry camping) is available. Please close all gates. No entry will be refunded if the trial cannot open or be completed by reason of riot, civil disobedience, fire and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee.

There will be no refunds for entries withdrawn after the closing date, or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal. Refunds will be issued for bitches that come in season, if notification in writing (email) is received before August 7th, 2009. Checks not honored by the bank do not constitute a valid entry. There will be a \$25.00 service charge for returned checks.

DIRECTIONS to the Ranch

From the south: take Highway 101 north, transition to Highway 1-Morro Bay at San Luis Obispo. You will travel through San Luis Obispo, Morro Bay and Cayucos. After passing through the town of Cayucos you will make a right on Villa Creek Road.

From the north: take Highway 101 south to Highway 46 - west (Hearst Castle, Cambria exit). Stay on Highway 46 for 22 miles to Highway 1. Turn left, south. Travel about 10 miles and make a left on Villa Creek Road.

Once you are on Villa Creek Road, travel about ½ mile and look for the flag at the entrance gate, follow the road through the bull field and park in the field.

MULTI-VENUE AWARD

We will offer a prize and rosette to the high score Aussie and high score Other Breed. Scoring will be based on Saturday's stockdog and agility trial scores. You will be responsible for submitting your scores. We will accept your high score from the stockdog trial + an additional 5 pts. for an additional qualifying stockdog trial score. Agility scores must come from the regular classes. Elite Q = 100 pts, faulted Q = 95 pts. Open Q = 90 pts, faulted Q = 85 pts, Novice Q = 80 pts, faulted Q = 75 pts. An additional 5 pts. can be earned from an additional Q in any regular or gamblers class on Saturday.

1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA® and any other rules and regulations appearing in the premium for this event.

1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to, the condition of the grounds, lighting, security measures or lack thereof, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals, and people; exhibitor/owner assumes the risk of any harm arising for these.

1.5 Exhibitor/owner releases ASCA® (including all officers, directors employees, and members), COAST, including all officers, directors, members and organizing committee/s, and the owners of Flying E Ranch and the Warren family and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Beginning 1/1/2003 for non-ASCA® registered dogs – In order to have ASCA® qualifying legs tracked and to receive ASCA® titling certificates, each non-ASCA® registered dog will be required to have an ASCA® Tracking Number. **This is a one-time fee of \$10/dog.** At the time of applying for the tracking number, **the individual owner must also be an ASCA® member** (minimum membership type of 'Service' is required). ASCA® membership does not need to be maintained in subsequent years. It will be the responsibility of the owner to identify to ASCA® the shows and legs earned when applying for a Tracking Number for those ASCA® qualifying legs earned from 1/1/2003 until submission of application.
