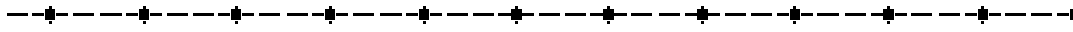

Overnight entries are not necessary. The **ASCA rules** state entries will be from a random draw filled by “postmark date order”. This is a very popular trial. We will do everything we can to accommodate all the entries so **PLEASE** get yours in on the opening date or you probably won't get in. No entry will be accepted if postmarked prior to the opening date. **Entries will open July 1st.** Please include your email address for faster confirmation of entries. I will **NOT** be sending US postal confirmations or calling to give verbal confirmations. Pre-entries must be postmarked no later than **July 15<sup>th</sup>** to be accepted at the “pre-entry” fee. Any entry postmarked after the closing date will be accepted at the day of trial entry fee, provided there is space available. Day of trial entries will be taken, space permitting, and will be taken from 7:00am to 7:30am all days.

**Foodstuff:** The infamous “Cook shack” will be open all weekend for lunches at a nominal fee. The Warren Family BBQ is on Saturday night. Sign ups will be taken for dinner at the Cook Shack during lunch or you can “pre-enter” by sending the money and a note with your entries. You **DON'T** want to miss this one. The food is GREAT!

**Other Important “Stuff”:**

- **Awards:** High Combined Awards will be given along with High Class awards. Placement ribbons will be given 1<sup>st</sup> to 4<sup>th</sup>.
- **Divisions will run for all classes of stock:** Advanced, Open, Novice, Junior, and Started.
- ALL ASCA Rules and Regulations will be enforced.
- All entries must be on the current official ASCA entry form (a link can be found on our website for the entry form or go to [www.asca.org](http://www.asca.org) and follow the links
- Bitches in season WILL run in order
- Run order will be posted day of trial
- Individuals will be responsible for **any** damage done to the stock and/or equipment
- Entries will not be refunded for any reason **after** pre-entries close. Please don't ask. Any cancellations **prior** to pre-entries closing will be cheerfully and fully refunded
- overnight camping is allowed at the trial site – there are no hook-ups

**Warren's Ranch Rules:** **NO SMOKING OUT OF YOUR CAR AND NO OPEN FIRES.** The **BULLS** have the right of way and need to be given a W-I-D-E berth. **ANYONE** caught hassling the cattle or horses will immediately be asked to leave. **NO dogs off leash** outside the trial arena -- ever! – if your dog is caught off leash, you may be asked to leave. *This includes running your dogs up on the hill.* This is a working ranch. Loose dogs can be a hazard. P-l-e-a-s-e **CLOSE ALL GATES** behind you (or behind someone else if they forget)!

**There will be several days of ASCA Agility Trials going on this weekend.**
