Membership

New applicants for membership must meet the following requirements:

1. Must provide proof of identity with a current, valid government issued photo ID at the time of application.
2. Must be 21 years of age, either a U.S. Citizen or legal resident.
3. Must provide proof of character in one of the following ways:
 - Present a current and valid Pistol Permit or CCW from Alabama or another state
 - Furnish a current criminal background check letter from the Alabama Criminal Justice Information Center indicating that the individual has no criminal convictions, or criminal arrest record of any type.
 - Current, valid, active duty military picture ID
 - Current, valid, law enforcement picture ID
4. Must be a current member of an organization *that actively supports* our full Second Amendment rights, and lobbies for the protection of all currently legal forms of gun ownership. Acceptable organizations include, but are not limited to the NRA, GOA, and JPFO.
5. Must be interviewed and approved by two or more HRPC officers or directors to determine if the applicant appears to have the necessary knowledge, skills, and attitude to conduct themselves safely with firearms at our range .

The Heritage Rifle and Pistol Club does not, and will not discriminate on the basis of race, sex, religion, physical disability, or national origin. We do reserve the right to deny membership to any individuals, who our officers or directors determine, do not to have the necessary knowledge, attitude, and skills for safe shooting and firearm handling based on the NRA's guidance for these issues as outlined in the formal NRA training and gun safety programs.

Membership requires a \$100.00 initiation fee*. Annual dues are \$125.00. The initial cost for new members may be calculated by adding the \$100.00 initiation fee to the dollar amount indicated in the schedule below.

Annual Dues Prorating Schedule

If a new member joins in the indicated month, their annual dues for the first year are:

January	February	March	April	May	June

- \$100 initiation fee still applies to new members, regardless of when they join.
- Initiation fee is waived for competitive shooters who have participated in at least 3 matches at the club in the last year. If a new member is currently a member in good standing of USPSA and they agree to participate in at least 3 matches in the current year, we will waive the initiation fee subject to audit of their participation at the end of the year. If they fail to compete in at least 3 matches during the current calendar year they will be assessed the full \$100 initiation fee before they can renew their membership.
- Existing members who renew or re-affiliate at a later date must always pay the full year dues no matter what month it is.
- Full year dues of \$125 are due in January every year for every member
- A \$25 late fee applies to existing member renewals paid after February 1st of each year
- Any member who has dropped out may pay the \$25 late fee and current year dues in full (\$125) to re-affiliate with the club. There is no proration of dues for past members who are re-affiliating with the club.
- Each member is required to participate in one designated club work day each year or pay an additional \$35 fee if they cannot or elect not to participate in one of those work days.
