BOOTHS: All booths consist of four tables (one (1) 8-foot x 30-inch front table, three (3) 6-foot x 30-inch tables (1 side, and 2 back)) and 6 chairs. The cost of each booth space is \$275. DEALERS may reserve booths with a \$100 deposit. Booth fees must be paid in full by June 25, 2009. Applications postmarked prior to May 22, 2009 and accompanied by payment in full may take a \$25 discount off their booth price (no discount for shared booth). The NEVADA STAMP STUDY SOCIETY may terminate without refund of deposit any agreements not fully paid by June 25, 2009. All applications received after June 25, 2009 must include payment in full. No part of the table fee is refundable in the event of a cancellation by the DEALER. The DEALER agrees that the table assigned will be used exclusively by him/her and employees. DEALERS will not be permitted to sub-let or allow any other dealer to operate from their table. Please identify any special set-up requirements:

PROGRAM AND STADIUM ADVERTISEMENT: We will include a section in the program with business card advertisements. Your advertisement will also appear on lighted stadium signage if signage is available. If you would like to have your card included, please mark the option and include the \$10 fee. Please include the business card you would like placed. If provided, dealer email and web page links will be included within the NSSS show web page (<http://home.earthlink.net/~renostamp>) at no additional cost.

SECURITY: Security will be provided from 4pm Friday July 24, 2009 until 6pm Sunday July 26, 2009. This includes during the hours the show is open as well as during the hours the show is closed. Dealers must check in before setting up. The NEVADA STAMP STUDY SOCIETY will not be liable for any kind of loss due to theft or any other cause. The DEALER agrees not to hold the NEVADA STAMP STUDY SOCIETY or the National Bowling Stadium responsible for any liability or claim for personal injury, property damage, or loss.

DISPUTES: The NEVADA STAMP STUDY SOCIETY shall in no way be a party to, nor responsible for, disputes or controversies regarding sales, purchases, and/or representations regarding stamps bought or sold at

the show. Any conduct the NEVADA STAMP STUDY SOCIETY, at their discretion, feels will bring discredit upon the show will be grounds for eviction.

TABLE COVERS: The NEVADA STAMP STUDY SOCIETY will provide table covers - Navy Blue in color. The DEALER agrees to use the covers to provide continuity of appearance of the Bourse section. The DEALER agrees to leave the arrangement of the tables and table covers as set up, and to keep the area neat and orderly. The DEALER agrees to use normal caution to prevent the table covers from becoming unnecessarily damaged or soiled.

SET-UP AND TEAR-DOWN: DEALER will be permitted to set up between the hours of 4:00 p.m. to 6:00 p.m. on Friday, July 24, 2009. If the DEALER chooses to set up Saturday morning, access to the Exhibit Hall will commence at 8:00 am, Saturday, July 25. DEALERS will be admitted to the Exhibit Hall at 9:00 a.m. on Sunday, July 26. Show hours are Saturday 10am to 6pm and Sunday 10am to 4pm. The DEALER agrees to keep the table open during all the hours the show is open to the public, and will not close down the table prior to actual closing time for the show on Sunday.

MISCELLANEOUS: Electrical outlets are available. You must provide your own extension cord and any additional lighting fixtures as you see fit. Dealers may use the freight elevator for load-in & load-out. Dealers will turn tax packets in to the Bourse Chair prior to checking out of the show.
