Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification of such a claim before judging commences.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for cleaning up after their dogs at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Show Me Agility Club of Central Missouri has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC Entry Forms or copies and must include the signed Agreement and Rules. Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Dogs under 6 months of age are not permitted on the show grounds of AKC Agility Trials.

Show Me Agility Club of Central Missouri does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

- Ring size: 90' x 100'. Trials will be held indoors, on 3/4 inch rubber flooring.
- Trial hours on Friday are 10am to 4pm.
- Friday Walkthrough and judges briefing will start at 11:30pm.
Judging will start at 12:00pm
- Trial hours on Saturday and Sunday are 7:00 am to 4:00 pm or end of judging.
- Walkthrough and judge's briefing will start at 7:30 am Saturday and Sunday,
Judging will start at 8:00 am both Saturday and Sunday.
- Food service is available at the trial site.
- **Crating Space is Limited** - Xpens for multiple dogs ONLY (2 large or 3+ small)

Class Description

Please see the AKC Regulations for Agility Trials for current class descriptions. **Dogs must be entered only in Regular Classes or Preferred Classes with no crossover between them allowed at the same set of trials.**

Height Divisions

Owners are responsible for entering their dogs in the proper height divisions. Height divisions are:

Regular	Preferred	Height at the withers
8 inches	4 inches	11 inches and under
12 inches	8 inches	14 inches and under
16 inches	12 inches	18 inches and under
20 inches	16 inches	22 inches and under
24 inches	20 inches	over 22 inches
26 inches	N/A	at owner's discretion

Dogs Eligible to Enter

This trial is open to all dogs over the age of 15 months that are registered with the American Kennel Club, including ILP/PAL registration, and Approved FSS breeds, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance. Refer to Chapter 1 Section 14 of the Obedience Regulations for further restrictions. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials. **Weave Poles have 24 inch spacing.**

Electronic Timing

Electronic timing will be used at these trials.

Prizes and Awards

Rosettes will be awarded to 1st through 4th Place in each jump height, in each class. Ribbons will be awarded to all dogs receiving a qualifying score. A jump bar and MACH/PAX rosette will be awarded to any handler finishing a MACH/PAX title. Key chains for everyone earning a Double Q in ExB St/ExB JWW. New Title rosettes will be awarded to all dog/handler teams completing a title. Junior Handlers earning a Qualifying score will receive an additional rosette.

Vendors

Vendors are welcome at the trial. Indoor vendor space is very limited. Outdoor space is available. Reservations are required. The vendor fee is \$20 for the weekend. To reserve a spot please contact Ginger Huxley, huxleyv@missouri.edu.

Running Order - Exact Running order, Class and Height will be determined after entries close.

AKC Height Cards

All dogs competing in Agility are required to present an official AKC Jump Height Card prior to running in an Agility Trial. All dogs, **except those jumping 24"** (unless a VMO or AKC Representative is present) without permanent or temporary height cards will be measured.

Please send a photocopy of your AKC Height Card with your entry.
By doing so, you may participate in Self Check-In.

Move-ups

Pre Entry Move ups CLOSE at 6:00 pm Central, Monday, October 26th.
 Day to Day move ups CLOSE at the end of the each day's trial.
"Day to Day" means you were entered that day and are changing you next day's entry.

It is recommended that Move-ups be sent by email. list owner name, dogs call name and class to be moved to. If an email address is provided with your move-up, an email confirmation will be sent.

Entry Fees

\$22.00 for the first entry for each dog in either class and \$12.00 for the second entry of the same dog in either class per day (includes AKC fee - \$3.00 per entry per day).

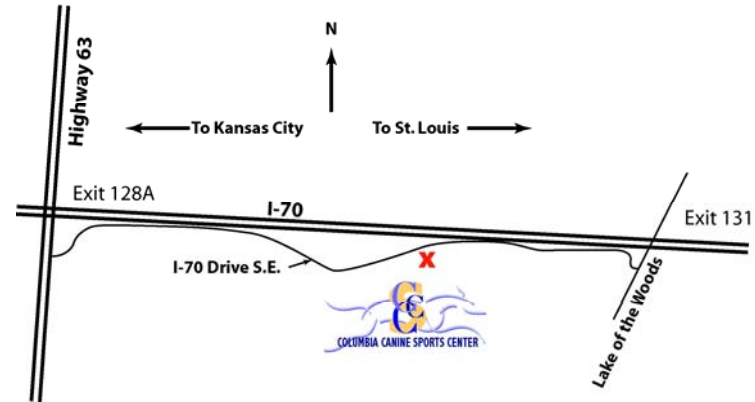
Entries **CANNOT** be changed once the trial has closed. **Please check your entries!**

FROM WEST. Take I-70 to the I-63 exit (#128A). Turn South on Hwy 63, then left at the first light (get in the leftmost right turn lane on the exit ramp, which is I-70 drive S.E. CCSC is 1.3 miles on the right.
FROM EAST, take I-70 to the Lake of the Woods exit (#131). Turn Left (South) over I-70 then immediately right on the access road I-70 Drive S.E. (Turn before the gas station, do not go to the light) CCSC is 1 mile on your left.
FROM NORTH OR SOUTH: Take Highway 63 to I-70 Dr.S.E. Turn east; CCSC is 1.3 miles on right.
