Measuring:

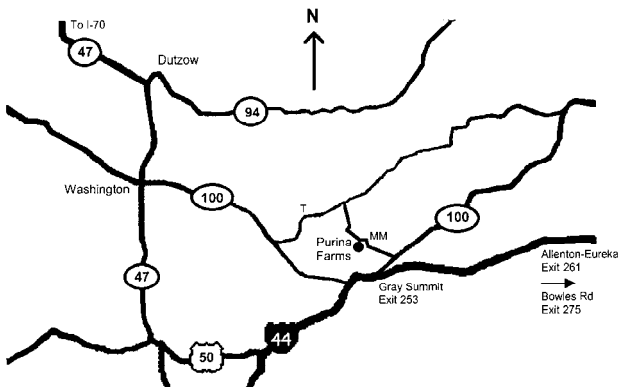
Dogs with out measurement cards running on Monday will be measured by the Judge prior to judging.
